

Grandstreet Theatre School Mini Camps and Big Camp

COVID 19 UPDATED POLICY AND PROCEDURE CHANGES

1. All participants will have their temperatures taken at arrival to the theatre. Anyone with 100 degree temperature or above will be sent home immediately.
 - a. The individual must go three days without a 100 degree fever (without the use of fever reducing medication) before returning to the theatre.
 - b. As always, we will continue to encourage parents to be on alert for signs of any illnesses and to keep children home if they are unwell.
2. All participants and staff must wear a mask while attending rehearsals or class when deemed necessary by a staff member when social distancing is not maintained.
 - a. Students and instructors who are in a larger space and are distanced over 6 feet may not have to wear a mask*
3. All participants and staff must observe physical social distancing of 6 feet during class and rehearsal time.
 - a. Signage and designated areas during both learning and break time will be posted to help students and instructors stay on track with physical social distancing guidelines.
 - b. Instructors may have to assist a student at a proximity closer than 6 feet. If this is necessary the instructor must have a mask on and use hand sanitizer prior to the assistance particularly if they will be handling materials with a student.
4. Instructors will disinfect all learning areas in use by their students before and after class
 - a. Instructors and staff will also be asked to disinfect surfaces, class materials, props and costumes as needed during class time and after.
5. Staff, instructors and students will make it routine to wash hands before class time, at snack time, and before leaving the theatre.
 - a. Hand sanitizing stations will also be placed in each area in use.
6. Rules regarding snack/break time during classes and summer camps:
 - a. All students must bring their own water bottle with their name clearly labeled on it.
 - b. Grandstreet Theatre school will serve only packaged snacks during summer camp snack time. (Beanies only)
 - c. Instructors must wear disposable gloves while serving snacks.
 - d. Students may not share snacks or drinks at any time
 - e. (Beanies only) Students will be asked to refrain from bringing in food from home for snack time unless they need to do so for a medical or

- allergy related reason. Parents must let instructors or the Education Coordinator know in advance if they need to bring snacks from home.
7. Students may not share personal items or class materials/items that are assigned to them.
 - a. Class materials and items include but are not limited to: general classroom materials, art materials, papers, scripts, props, tools, protective wear, and costuming.
 - b. Personal items include but are not limited to: Clothing, personal hygiene items, snacks, toys, sensory needs, books, phones and miscellaneous electronic devices.
 8. Each group will have a designated hand washing space and time.
 9. All students will go straight to their showcase rehearsal spaces in the morning (no big gathering in the theatre) for the opening of camp (9:00 a.m.) and we will do something fun with them in a small group. They will stay with that group throughout the day.

We encourage you to continue practicing recommended sanitary standards by the CDC and ask that you only plan to be in attendance if you are feeling in good health. And as always, please wash your hands!
